#### **Dear Baltimore Alumni -**

Welcome back to Baltimore! It's been 18 months since Homecoming Amplify took place in May of 2022, and this will be our fourth Baltimore Homecoming since we launched in 2018. As we thought about what comes after Amplify - after amplifying and growing our alumni network and after sharing the stories of Baltimoreans - we knew it was time to Activate. This means we're ready to turn inspiration into commitment and commitment into action.

Over the first couple of years, it was important for Baltimore Homecoming to expand our network, but now it is about cultivating those relationships so that our connections move beyond greetings and into the kind of relationship capital that can be transformative for our city. Building meaningful relationships takes effort and time. As a way to deepen connections and to meet Baltimoreans where they are now located, Baltimore Homecoming hosted 11 regional gatherings in 9 cities across the U.S. in 2023. We met with more than 125 Baltimore alumni and connected them with our inspiring community partners.

In 2022, 5 years after the launch of Baltimore Homecoming, we looked back. Baltimore Homecoming has built a network of over 1,000 accomplished Baltimore alumni, engaged over 675 local leaders, and sparked over 2,000 new relationships. We've infused more than \$1million into our nonprofit sector. But what's more impressive is that we've seen our community partner organizations collectively grow \$14million in budget size. The power of relationships is hard to track and measure, but we've begun to aggregate all the ways in which the Homecoming network has impacted our city through the movement of social, intellectual, and financial capital. # **SPECIAL GUESTS**

**GOVERNOR WES MOORE** Wes Moore is the 63rd Governor of the state of Maryland. He is Maryland's first Black Governor in the state's 246-year history, and is just the third African American elected Governor in the history

of the United States. Moore is a proud graduate of Valley Forge Military Academy and College, where he received an Associate's degree in 1998, and was commissioned as a second lieutenant in the U.S. Army. Afterward, he went on to earn his Bachelor's in international relations and economics at Johns Hopkins University in Baltimore, where he graduated Phi Beta Kappa. While at Johns Hopkins, Moore interned in the office of former Baltimore Mayor Kurt Schmoke. Moore was the first Black Rhodes Scholar in the history of Johns Hopkins University. As A Rhodes Scholar, he earned a Master's in international relations from Wolfson College at Oxford. Moore and his wife Dawn Flythe Moore have two children – Mia, 12; and James, 9.



#### MAYOR BRANDON SCOTT Brandon M. Scott is the 52nd Mayor of Baltimore, working to end gun violence, restore the public's trust in government and change Baltimore for the better. Scott was unanimously elected President of the

Baltimore City Council by his colleagues in May 2019. As Council President, Scott developed and released the first-ever City Council President legislative agenda, focused on building safer, stronger communities, cleaning up city government, investing in Baltimore's young people, and centering equity. Mayor Scott is a community leader, public servant, and lifelong resident of Baltimore City. A proud Baltimorean, Scott is a graduate of MERVO High School and St. Mary's College of Maryland. He lives in Baltimore's Frankford neighborhood in Northeast Baltimore.






# **INNER HARBOR**

Harborplace opened on July 2, 1980, as a centerpiece of the revival of downtown Baltimore. Founded in 1729 around this bustling port, Baltimore quickly emerged as a thriving center for trade, shipbuilding, and fishing. During the War of 1812, the sight of the American flag flying over Fort McHenry after British Naval Attacks inspired Francis Scott Key to pen "The Star-Spangled Banner." In the mid-20th century, facing economic decline, Baltimore initiated an ambitious urban renewal project to rejuvenate the Inner Harbor. This transformative effort spurred development including the Baltimore Inner Harbor stands as a symbol of the city's maritime heritage and is a vibrant nexus for tourism, commerce, and cultural activities.



# **BALTIMORE PENINSULA**

Formerly a busy industrial workhorse from 1914, Port Covington has been reclaimed and renamed "Baltimore Peninsula" The transformation of the old defunct port into an economic engine for Baltimore City through the creation of a true live, work, play neighborhood is one of the biggest current development projects in the country. The site overlooking the Patapsco River now hosts a newly built, 235-acre community led by MAG Partners and MacFarlane Partners and featuring investments from Sagamore Ventures and the Urban Investment Group within Goldman Sachs Asset Management. Ultimately, the master-planned development will include 14 million square feet of structures, 2.5 miles of restored waterfront, and 40 acres of parks and green space. From wellness classes, waterfront events, concerts and movie nights, Baltimore Peninsula is activated throughout the year and invites all to come and enjoy the treasured spirit of Baltimore.






### About The Crab Tank Pitch Competition

# UPTON

Upton's history is a tapestry of architectural magnificence and transformation. In the 1830s, lawyer David Stewart commissioned the construction of a grand country villa designed by architect Robert Carey Long, Jr., which still stands today as the last surviving Greek Revival country house in Baltimore. Over the years the mansion changed hands, serving as a social hotspot for lavish parties, a radio station (WCAO) in 1930, and as the Baltimore Institute of Musical Arts, which provided education for African American students in the 1940s. The Baltimore City School System later occupied the building until 2006. In 2022, federal funding helped beautifully restore and transform the Upton Mansion into a community center which houses and showcases Baltimore's Afro news organization's valuable archives.





#### **JAMES PIPER BOND PRESIDENT & CEO**




# **GREENMOUNT WEST**

Greenmount West, a historic Baltimore neighborhood, was established in the 19th century as a residential area for workers in nearby factories. Over time it has transformed into a vibrant hub for arts and culture. The emergence of the Station North Arts and Entertainment District has made Greenmount West a center for creativity and a lively arts scene. It boasts galleries, theaters, and studios that attract artists and creative professionals. Maryland Institute College of Art (MICA) is integral to the neighborhood's cultural and educational fabric. The Lebow Building's reinvention as the Baltimore Design School in 2013 stands as a testament to historic preservation and state and federal tax credits. Additionally, the historic 1600 Guilford Ave. building has continued its educational legacy as home to the Baltimore Montessori Public Charter School, serving Baltimore City's children. The building also gained fame as the location for the fictional Edward J. Tilghman Middle School in HB0's "The Wire." # **BROMO ARTS DISTRICT**

The Bromo Arts District, originally known as the Bromo-Seltzer Arts District, draws its name from the iconic Bromo-Seltzer Tower, a testament to early 20th-century Baltimore architecture that was once the city's tallest building. Its roots date back to the late 19th and early 20th centuries when the district thrived as a bustling center of manufacturing and commerce. In the early 2000s, the Bromo-Seltzer Arts Tower underwent a transformation, becoming artist studios and apartments that would later serve as a focal point for Baltimore's burgeoning arts community. Today, the Bromo Arts District is home to a variety of cultural institutions, galleries, theaters, and performance spaces, including the Maryland Art Place (MAP), the Eubie Blake National Jazz Institute and Cultural Center, and the Hutzler Brothers Palace Building, housing artist studios.


